



VOLUNTEER RELEASE OF LIABILITY AND ASSUMPTION OF RISK

One Tree Hill Live Watch Party Tour/ Antwon Tanner Entertainment, LLC

In consideration of being permitted to volunteer at events produced by Antwon Tanner Entertainment, LLC ("ATE"), including the One Tree Hill Live Tour (the "Event"), I, the undersigned volunteer, acknowledge and agree to the following:

1. Voluntary Participation. I am participating as a volunteer of my own free will. I understand that I am not an employee, agent, or contractor of ATE, and that I will not receive wages, benefits, or workers' compensation coverage in connection with my volunteer service.
2. Assumption of Risk. I understand that volunteering at a live event involves inherent risks, including but not limited to: physical injury from lifting, moving equipment, or navigating crowded venues; slips, trips, and falls; interactions with large crowds; travel to and from the venue; and other hazards that may arise in an event environment, whether or not foreseeable. I knowingly and voluntarily assume all such risks, both known and unknown, and accept full personal responsibility for any injury, illness, loss, or damage I may suffer in connection with my volunteer service.
3. Release and Waiver. To the fullest extent permitted by law, I hereby release, waive, and discharge ATE, its owners, officers, employees, contractors, talent, sponsors, venue partners, and affiliates (the "Released Parties") from any and all claims, demands, causes of action, or liabilities of any kind arising out of or related to my volunteer service, including those caused by the ordinary negligence of the Released Parties. This release does not extend to acts of gross negligence or intentional misconduct.
4. Indemnification. I agree to indemnify and hold harmless the Released Parties from any claims, damages, or expenses (including reasonable attorneys' fees) arising from my own actions, omissions, or negligence while serving as a volunteer.
5. Medical Authorization. In the event of an injury or medical emergency during my volunteer service, I authorize ATE and event staff to secure emergency medical treatment on my behalf. I understand that I am solely responsible for any resulting medical costs, and I represent that I have no physical or medical condition that would make my participation unsafe.



6. Personal Property. I understand that ATE is not responsible for the loss, theft, or damage of any personal property I bring to the Event.
7. Compliance with Instructions. I agree to follow all reasonable instructions given by ATE staff and event leadership, as well as all venue rules and applicable laws. I understand that failure to do so may result in immediate removal from my volunteer role.
8. Age Requirement: I certify that I am at least 18 years of age as of the date of the Event.
9. Governing Law. This Release shall be governed by and construed in accordance with the laws of the State of Florida, without regard to its conflict of law principles. Any disputes arising under this Release shall be resolved in the state or federal courts located in Florida.
10. Severability. If any provision of this Release is found to be unenforceable, the remaining provisions shall remain in full force and effect.
11. Acknowledgment. I have read this Release of Liability and Assumption of Risk in its entirety, I fully understand its terms, and I sign it freely and voluntarily. I understand that by signing, I am giving up substantial legal rights, including the right to sue the Released Parties.
